OSRC Goals for 2023-2026

Your Board of Directors developed goals that align with the AARC four pillars: Elevate, advocate, educate, and engage. Strategic action plans include:

- 1. Expand our media presence and community presence through our OSRC web site and social media.
- 2. Establish interprofessional rapport and understanding through district level interprofessional education and collaborative practice meetings as well as establishing and growing conversations with other healthcare professional organizations such as, Ohio Hospital Association, Ohio Pharmacy Association, Ohio Nursing Association, Ohio Association of Medical Equipment Services, and Ohio Association of Cardiovascular and Pulmonary Rehabilitation.
- 3. Establish and maintain regular communication with membership through quarterly newsletters and website.
- 4. Optimize communication with OSRC members through use of our state affiliate AARC Connect group.
- 5. Engage members through participation in committees and attendance at Board meetings.

- 11. Promote AARC opportunities for continuing respiratory continuing education (CRCE) credits.
- 12. Create an asynchronous 1-CRCE credit OSRC Ethics education program to include review of Ohio law and rules governing respiratory care professional practice.
- 13. Provide high quality relevant continuing education through the OSRC Annual Conference and Meeting July, 2023 and OSRC Diagnostic & Sleep Conference in 2024.
- 14. Grow and promote student scholarship opportunities through the OSRC Foundation.
- 15. Promote the excellent work of respiratory care professionals and healthcare industry partners through Practitioner of the Year and Center of Excellence awards.
- 16. Recognize and promote outstanding healthcare industry partners and education programs through OSRC newsletter spotlight column.

2023 AARC Apex Recognition Award Recipient Right in our back yard



The Ohio State University Respiratory Therapy program in the School of Health and Rehabilitation Sciences has been recognized by the American Association for Respiratory Care (AARC), as a recipient of the 2023-2024 Apex Recognition Award. Ohio State joins an elite group of respiratory care educational programs from across the U.S. who have met the stringent quality, clinical practice or educational program criteria of the award. Only 11 out of 423 educational programs in the country meet the criteria to earn this prestigious honor this year.

The Apex Recognition Award distinguishes programs for their commitment to excellence in professional development and the education of respiratory therapists to deliver the highest quality care and elevate the respiratory therapy profession.

The Ohio State Respiratory Therapy program was established in 1971 with the mission to prepare advanced-level therapists who can provide leadership for the ongoing development of the profession. The program has been highly successful, awarding baccalaureate degrees for over 50 years and is nationally recognized for excellence. The Respiratory Therapy baccalaureate program has continued accreditation from the Commission on Accreditation for Respiratory Care (CoARC) and has received its 2022 President's Award for Excellence in Credentialing Success and its Distinguished RRT Credentialing Success Award for the past eight years in a row.



Limited permit and licensing timeline

OSRC Licensing Update

Limited Permit Holder License Expiration Are you a student or recent graduate? Are you an educator? Do you manage student employees? As of October 2021, limited permits expire one year from date of issuance. Another constraint to these special licenses: respiratory therapists may only work under a limited permit up to one year from the date of graduation. Depending on when the application is submitted, the expiration date listed on the SMBO License lookup website may be incorrect. Care must be taken to ensure LPHs are working with an active license, meaning it has been less than one year following graduation.

Example Timeline: "Sam" is excited to start earning money while still in school to become a Respiratory Therapist. He applied as a limited permit holder (LPH) in August 2022 and enters into the workforce. He graduates in May 2023 and continues to work under his limited license. Time gets away from him and his manager does not require him to earn his RRT to remain employed. He renews his limited permit in August 2023 and continues to work. When does his limited permit expire?

Although you can apply for and renew an LPH in one-year intervals, the Ohio Revised Code makes a stipulation that you cannot continue to work under a limited permit one year past your graduation date. Therefore, Sam's LPH expires in May 2024.

Columbus State Community College Paves the Path Forward Respiratory Cohort Success


The first sponsored part-time cohort will be graduating this May. These students are employees of Nationwide Children's hospital and will transitioning to full-time positions at NCH upon graduation. In addition, all students from the 2022 cohort successfully completed their board exams on their first attempt and are now RRTs.

OhioHealth is expanding

New Albany Medical Camps is now open, complete with urgent care, an athletic performance clinic, onsite retail pharmacy and more. Additionally, OhioHealth Welcomes Van Wert Hospital, Guernsey County Hospital and Southeastern Medical Center in Cambridge to the OhioHealth network. Coming late 2023, OhioHealth Pickerington Methodist Hospital will bring new life-extending and lifesaving capabilities to the community with a \$140 million investment that will expand the current campus, including, Cancer Care (Infusion), Women's Health, Trauma (Level III), Heart and Vascular (Diagnostic and Interventional Cath Labs), Acute Stroke Program, General Medicine, General Surgery and more. I making 60 total beds (includes dedicated ICU, medical surgical beds and post-partum beds), 6 operating rooms, 2 Csection operating rooms. Finally, OhioHealth Announces Transformation of OhioHealth Grant Medical Center! Grant will increase by about 310,000 square feet (Ambulatory facility and parking garage will be approximately 40.000 square feet of medical office building space and a fivestory parking garage; Emergency department/critical care pavilion will be approximately 270,000 square feet with underground parking). Construction will begin in mid-2023 and is expected to be completed in mid-2028

APRT Update

Update on Advanced Practice Respiratory Therapist (APRT) Licensing

On behalf of the OSRC Legislative Committee

Since 2019, the OSRC Legislative Committee and OSRC Lobbyist David Corey have been working diligently toward establishing licensure for the Advanced Practice Respiratory Therapist in Ohio. Following three interested party meetings in 2020, feedback from stakeholders was used to edit the proposed licensure language to all an introduced bill to move forward without significant opposition. After drafting by the Legislative Services Commission, Representative Tom Young and Representative Marilyn John introduced House Bill 714 on August 31, 2022. Unfortunately, HB 714 was

not scheduled for committee hearings in 2022, and the legislative session ended on December 31, 2022. The 135th General Assembly began in January 2023, and both Representative Young and Representative John committed to reintroducing the APRT licensing bill. On March 14, 2023, HB 102 "License Advanced Practice Respiratory Therapists" was introduced, and on March 22, 2023 it was assigned to the House Health Provider Services Committee (https://www.legislature.ohio.gov/legislation/135/hb102 [legislature.ohio.gov]).
