#### State Advocacy

Our active Legislative Committee, under the leadership of Courtney Kallergis, have been making great strides towards establishing a new licensed Advance Practice Respiratory Therapist in Ohio. HB 102 License Advanced Practice Respiratory Therapist was introduced by Reps. T. Young and M. John sent to the House Health Services Provider committee. If you would like to read and track the bill it is available online through the House Bill 102 link. The committee heard sponsor testimony May 23 and proponent testimony June 6. Proponent testimony was given by Dr. Karen McCoy a pediatric pulmonary specialist at Nationwide Children's Hospital, Dr. Emily Amin, a pulmonary and critical care specialist from the Ohio State University Wexner Medical Center, and three OSRC members (Nancy Colletti, Courtney Kallergis, and Sarah Varekojis). You may view a recording of proponent testimony on <u>The Ohio Channel</u>. We are currently waiting for a third hearing to be scheduled in which the committee will hear opponent and interested party testimony. Please reach out to your state house representative and encourage them to support HB 102. - Provide high quality relevant continuing education through the OSRC Annual Conference and Meeting July, 2023 and OSRC Diagnostic & Sleep Conference in 2024.
- Grow and promote student scholarship opportunities through the OSRC Foundation.
- Promote the excellent work of respiratory care professionals and healthcare industry partners through Practitioner of the Year and Center of Excellence awards.
- Recognize and promote outstanding healthcare industry partners and education programs through OSRC newsletter spotlight column.

#### **APRT Bill**

HB 102: "License Advanced Practice Respiratory Therapists" was introduced to the Ohio House by our sponsors, Representatives Tom Young and Marilyn John on March 14, 2023. The bill has been assigned to the House Health Provider Services Committee. Sponsor testimony was provided on May 2, and proponent testimony was provided on June 6.

The APRT is a new professional, an advanced practice provider who will work for pulmonologists, intensivists, anesthesiologists, and sleep specialists (pediatric and adult) to manage patients with cardiopulmonary conditions. These physician groups nationally identified a need for an advanced practice provider with cardiopulmonary expertise.

#### AARC PACT Update

Mentor Hospital opens to patients on July 11. The new facility will expand Cleveland Clinic's services and care to the residents of Lake and Geauga counties.




#### The facility will feature:

## Allied Health Workforce Diversity Act of 2021

This bill allows the Department of Health and Human Services to provide grants to accredited education programs to increase diversity in the physical therapy, occupational therapy, respiratory therapy, audiology, and speech-language pathology professions. Grants may be used to provide scholarships or to support recruitment and retention of students from underrepresented groups.

- The Allied Health Workforce Diversity Act is now Law signed by President Biden including into the final omnibus spending bill of the 117th Congress
- Celebrate our success and share this information with RTs in your state


Thank you to all who have worked long and hard to get this important piece of legislation through Congress in support of our profession.
